A comprehensive vitamin and mineral supplement and the coccidiostat Bovatec® are included to enhance development of the immune system and as an aid in the control of coccidiosis.

Recommended feeding rate:

- Specially formulated for feeding to calves from 3 days of age up until weaning.
- Feed *ad lib*, starting with small amounts increasing gradually up to 1kg per calf per day depending on the age and weight.
- Calves can be weaned when eating 1kg of meal each day for three consecutive days.
- Ensure that fresh feed is offered at least daily and that fresh clean water is available at all times.

Feed 500g **Sgt Dan PREMO CALF MEAL** per 45kg calf to provide 1mg/kg lasalocid per day.

Wheat, Barley, Grain By-Products, Vegetable Proteins, Oilseed Meals, Molasses, Vegetable Oils, Limestone, Salt, Dicalcium Phosphate, Vitamins and Trace Minerals, Bovatec®, Flavouring.

Premo Calf Meal is formulated without PKE.

Caution:

DO NOT allow dogs, horses or other equids access to feeds containing Bovatec® as ingestion by these species may be fatal.

This product must not be used for growth promotion in ruminants intended for human consumption. Care must be exercised when feeding concurrently with other antimicrobials.

DO NOT feed with other ionophores e.g. monensin capsules, liquid or premix.

DO NOT exceed recommended dose rates.

NOT to be used for single dose treatment.

Withholding periods: It is an offence for users of this product to cause residues exceeding the relevant MRL in the New Zealand (Maximum Residue Limits of Agricultural Compounds) Food Standard.
