**Sgt Dan SUPER 15 CALF PELLETS** is a premium calf grower feed containing a blend of cereals and quality protein meals, selected for their high feed value. Starch in cereal grains helps encourage early rumen development, while protein meals provide amino acids essential for lean tissue development. A comprehensive vitamin and mineral supplement and the coccidiostat Bovatec<sup>®</sup>, are included to enhance development of the immune system and as an aid in the control of coccidiosis.

### **Recommended feeding rate:**

- Ideal for calves from weaning until 100kg.
- Feed *ad lib*, between 1 and 2kg per calf per day depending on the age and weight.
- Ensure that fresh feed is offered at least daily and that fresh clean water is available at all times.

Feed 1kg **Sgt Dan SUPER 15 CALF PELLETS** per 90kg calf to provide 1mg/kg lasalocid per day.
